THIS AMENDMENT NUMBER 3 is by and between the State of Louisiana ("Participating State") and Pitney Bowes Inc. ("Contractor").

WHEREAS, the State of Arizona ("Lead State") has a Contract with the Contractor identified as Master Agreement No. CTR058808 effective May 15, 2022 through May 14, 2027, to provide Mailing Equipment, Supplies; and Maintenance; and

WHEREAS, the State of Louisiana and Pitney Bowes Inc. have executed a Participating Addendum, which is administered and utilized by the State of Louisiana as State Contract Number 4400025167; and

WHEREAS, the terms of the Participating Addendum specifically state that the Participating Addendum may be amended per agreement by both parties.

NOW, THEREFORE, it is agreed by the parties to amend the Participating Addendum as follows:

Changes:

1. **Section 3. Term**, revised to read as follows:

The term of this Participating Addendum and State Contract Number 4400025167 shall be effective October 24, 2022 through **May 14, 2027**, unless otherwise terminated in accordance with the termination provisions of this Participating Addendum or the Master Agreement. This Participating Addendum and State Contract Number 4400025167 may be extended in accordance with the terms and conditions of the Master Agreement.

All other provisions, terms and conditions of the Participating Addendum shall remain in full force and effect. The original Participating Addendum and all Amendments constitute the entire Participating Addendum between the State and the Contractor. Any other oral or written communications between the parties before or after its execution shall not alter its effects, unless the change or modification is in writing and signed by authorized representatives of the State and the Contractor. In the event of a conflict between the terms and conditions of the Participating Addendum and this Amendment Number 3 the terms and conditions of this Amendment Number 3 shall prevail.
