**THIS AMENDMENT NUMBER 2** is by and between the State of Louisiana ("Participating State") and Pitney Bowes Inc. ("Contractor").

**WHEREAS**, the State of Arizona ("Lead State") has a Contract with the Contractor identified as Master Agreement No. CTR058808 effective May 15, 2022 through May 14, 2026, to provide Mailing Equipment, Supplies; and Maintenance; and

**WHEREAS**, the State of Louisiana and Pitney Bowes Inc. have executed a Participating Addendum, which is administered and utilized by the State of Louisiana as State Contract Number 4400025167; and

**WHEREAS**, the terms of the Participating Addendum specifically state that the Participating Addendum may be amended per agreement by both parties.

**NOW, THEREFORE**, it is agreed by the parties to amend the Participating Addendum as follows:

**Changes:**

1. **Section 3. Term**, revised to read as follows:

The term of this Participating Addendum and State Contract Number 4400025167 shall be effective upon the date of final execution below (the "Effective Date") by the State of Louisiana through **May 14, 2026**, unless otherwise terminated in accordance with the termination provisions of this Participating Addendum or the Master Agreement. This Participating Addendum and State Contract Number 4400025167 may be extended in accordance with the terms and conditions of the Master Agreement.

2. ADD, the following language to Section 5. **Modifications and/or Additions to the Master Agreement:**

**Y. Prohibition of Companies that Discriminate Against Firearm and Ammunition Industries:**

In accordance with La. R.S. 39:1602.2, the following applies to any contract with a value of \$100,000 or more involving a for-profit company with at least 50 full-time employees:



Unless otherwise exempted by law, by entering into this Participating Addendum, the Contractor certifies the following:

1. The company does not have a practice, policy, guidance, or directive that discriminates against a firearm entity or firearm trade association based solely on the entity's or association's status as a firearm entity or firearm trade association;
2. The company will not discriminate against a firearm entity or firearm trade association during the term of this Participating Addendum and State Contract number 4400025167 based solely on the entity's or association's status as a firearm entity or firearm trade association.

The State reserves the right to terminate this Participating Addendum, State Contract Number 4400025167, or any order issued pursuant to State Contract Number 4400025167 if this certification is subsequently determined to be false, or if the certification is no longer true.

All other provisions, terms and conditions of the Participating Addendum shall remain in full force and effect. The original Participating Addendum and all Amendments constitute the entire Participating Addendum between the State and the Contractor. Any other oral or written communications between the parties before or after its execution shall not alter its effects, unless the change or modification is in writing and signed by authorized representatives of the State and the Contractor. In the event of a conflict between the terms and conditions of the Participating Addendum and this Amendment Number 2, the terms and conditions of this Amendment Number 2 shall prevail.
