

AMENDMENT NUMBER 3

TO

CONTRACT NO. 4400015965

This Amendment No. 3 to Contract No. **4400015965** (the Contract) is by and between Pitney Bowes Inc. (“Contractor”) and the Commonwealth of Pennsylvania, acting through the Department of General Services (“DGS”).

WHEREAS, the Contractor and DGS entered into the Contract, identified as SRM No. **4400015965**, for the provision of Mailroom Equipment beginning with contract execution, 9/1/2016 and ending 11/30/2021;

WHEREAS, the Commonwealth has extended the contract twice prior via a sole source amendment (Amendment 1) until 7/31/2022 and (Amendment 2) until 12/31/2022 under the same terms and conditions;

WHEREAS, the Commonwealth would like to extend the contract via a sole source amendment until 6/30/2023 under the same terms and conditions;

WHEREAS, the Contractor agrees to the sole source extension of the current contract; and

WHEREAS, all items currently governing the current contract will carry forth into the new contract till completion.

NOW THEREFORE, for valuable mutual consideration and intending to be legally bound hereby, the parties agree as follows:

1. The sole source extension will run from 1/1/2023 till 6/30/2023.
2. That all items currently governing the current contract will carry forth into the new contract till completion.
3. This Amendment shall become effective when it is fully executed by the parties and all approvals required by Commonwealth contracting procedures have been obtained, as indicated by the date of the last Commonwealth signature. This Amendment is not binding in any way on the Commonwealth or the Department until it has been fully executed, as prescribed in the preceding sentence.
4. Except as amended by this Amendment Number 3, all other terms and conditions of the Contract shall remain as originally written.
