## SECTION 4: FIRST AID MEASURES

### 4.1 Description of First Aid Measures

**Sensitization:** This product is not expected to cause sensitization. None of the components are respiratory or skin sensitizers.

**Specific Target Organ Toxicity:**

Single Exposure: None known.

Repeat Exposure: In a study in rats of chronic inhalation exposure to a typical toner, a mild to moderate degree of lung fibrosis was observed in 92% of the rats in the high concentration (16 mg/m<sup>3</sup>) exposure group. A minimal to mild degree of lung fibrosis was observed in 22% of the rats in the middle (4 mg/m<sup>3</sup>) exposure group. No pulmonary change was reported in the lowest (1 mg/m<sup>3</sup>) exposure group, the most relevant level to potential human exposures.

**Carcinogen Status:** None of the components of this product at greater than 0.1% are classified as carcinogens by IARC, OSHA, NTP, ACGIH, or the EU CLP.

**Germ Cell Mutagenicity:** This product is not expected to be a mutagen.

**Toxicity for Reproduction:** This product is not a reproductive hazard.
