SECTION 4: FIRST AID MEASURES

4.1 Description of First Aid Measures

Sensitization: This product is not expected to cause sensitization. None of the components are respiratory or skin sensitizers.

Specific Target Organ Toxicity:

Single Exposure: None known.

Repeat Exposure: In a study in rats of chronic inhalation exposure to a typical toner, a mild to moderate degree of lung fibrosis was observed in 92% of the rats in the high concentration (16 mg/m³) exposure group. A minimal to mild degree of lung fibrosis was observed in 22% of the rats in the middle (4 mg/m³) exposure group. No pulmonary change was reported in the lowest (1 mg/m³) exposure group, the most relevant level to potential human exposures.

Carcinogen Status: IARC has classified carbon black and titanium dioxide as group 2B carcinogens (possible human carcinogen). The carbon black and titanium dioxide in this product are inextricably bound within a polymer matrix and will not present a risk of exposure. None of the other components of this product at greater than 0.1% are classified as carcinogens by IARC, OSHA, NTP, ACGIH, or the EU CLP.

Germ Cell Mutagenicity: This product is not expected to be a mutagen.

Toxicity for Reproduction: This product is not a reproductive hazard.
