SECTION 4: FIRST AID MEASURES

4.1 Description of First Aid Measures

Eyes: Do not rub eyes. Flush with plenty of running cool to lukewarm water, holding eye lids open to assure thorough rinsing. Get medical attention if irritation persists or for foreign body in the eyes.

Corrosivity: This is not a corrosive product.

Sensitization: This product is not expected to cause sensitization. None of the components are respiratory or skin sensitizers.

Specific Target Organ Toxicity:

Single Exposure: None known.

Repeat Exposure: In a study in rats of chronic inhalation exposure to a typical toner, a mild to moderate degree of lung fibrosis was observed in 92% of the rats in the high concentration (16 mg/m³) exposure group. A minimal to mild degree of lung fibrosis was observed in 22% of the rats in the middle (4 mg/m³) exposure group. No pulmonary change was reported in the lowest (1 mg/m³) exposure group, the most relevant level to potential human exposures.

Carcinogen Status: None of the components of this product are classified as carcinogens by IARC, OSHA, NTP, ACGIH, or the EU CLP.

Germ Cell Mutagenicity: This product is not expected to be a mutagen.
