VeriMove™ 3.5.3 supports all USPS® CASS™ NCOA<sup>Link®</sup> regulations announced at the 2010 NCOA<sup>Link®</sup> Conference. The VeriMove™ 3.5.3 release internal CASS™ processing fully supports the USPS® CASS™ Cycle N requirements. ## VeriMove™ Supported Releases

Support for VeriMove<sup>™</sup> 3.5.1 will end with the release of VeriMove<sup>™</sup> 3.5.3. We will only continue to support VeriMove<sup>™</sup> 3.5.2 for non-CASS users.

#### VeriMove™ Keys

To continue to use VeriMove<sup>™</sup> after July 31, 2013, you must install new NCOA<sup>Link®</sup> and Site Support keys by August 1, 2013. The new NCOA<sup>Link®</sup> and Site Support keys expire on August 1, 2014. Pitney Bowes Software currently supports the VeriMove<sup>™</sup> 3.5.2 (for non-CASS users) and 3.5.3 releases. Your new NCOA<sup>Link®</sup> and Site Support keys are valid for either release.

If you use the VeriMove<sup>™</sup> Internal CASS processing engine, your current Finalist<sup>®</sup> CASS<sup>™</sup> key expires on July 31, 2013. To continue using Internal CASS<sup>™</sup> Processing in a USPS<sup>®</sup> CASS<sup>™</sup> Cycle N certified mode, you must install a new Finalist<sup>®</sup> CASS<sup>™</sup> key by August 1, 2013.

The VeriMove<sup>™</sup> 3.5.3 release is the only VeriMove<sup>™</sup> release that supports USPS® CASS<sup>™</sup> Cycle N through June 24, 2014. To continue processing using Internal CASS<sup>™</sup> Processing in a USPS® CASS<sup>™</sup> Cycle N certified mode beyond July 31, 2013 and through June 24, 2014, you should plan on updating to VeriMove<sup>™</sup> 3.5.3 by July 31, 2013.

Information on your NCOA<sup>Link®</sup> key, Site Support key, and the Finalist<sup>®</sup> CASS<sup>™</sup> key for Internal CASS<sup>™</sup> Processing have been forwarded to you in a separate communication.

# Integration of VeriMove™ 3.5.3 with Finalist® 8.2.0

The VeriMove<sup>™</sup> 3.5.3 release includes integration of Finalist<sup>®</sup> 8.2.0 S01, a CASS<sup>™</sup> Cycle N certified product. The Finalist<sup>®</sup> 8.2.0 S01 release continues support for CASS<sup>™</sup> Cycle N through June 24, 2014.


#### **New VMA Client Executable Switches**

The VeriMove™ 3.5.3 release includes new vma.exe switches.

Switch	Description
-nobackup	Previously, vma.exe would backup all output files (Output 1 and 2, PSR, and 3553) in the jobdef folder. The new -nobackup switch allows users to overwrite the previous output files without creating a backup of the output files from the previous run.
-norename	Previously, vma.exe would not allow you to keep the default output files sent by the server. The -norename switch allows you to keep the default output files names sent by the server (instead of using the names in the job definition file).

#### **VeriMove Access Proxy Settings**

VeriMove Access will now use the proxy settings stored in the VeriMove Access configuration utility instead of using values specified on the command line (getfilehttps.exe). Clients who use proxy servers to connect to VeriMove Access can use the Move Update Configuration Utility to enable a proxy server.



The Move Update Configuration Utility can also be accessed from the VeriMove Main Menu at Tools > Options > VeriMove Access.

#### **Modernized and Expanded VeriMove Access Servers**


The VeriMove Access serves have been upgraded and expanded to better serve client needs.

#### **User Interface (UI) Changes**

The VeriMove™ 3.5.3 release includes User Interface (UI) changes.

#### CASS Tab, Internal CASS Processing Selected

Internal CASS processing now requires you to assign carrier route codes to the addresses in your input file. The Assign Carrier Routes field always displays in an enabled and grayed out mode as shown here.

## **Reporting Changes**

The USPS<sup>®</sup> recently began evaluating CSL reports for accuracy and proper formatting and will begin penalizing customers in the future for not complying with current regulatory standards for report submissions. VeriMove<sup>™</sup> 3.5.3 corrects several formatting issues that occurred in some environments.

## **Corrected Issues**

The VeriMove™ 3.5.3 release corrects the following issue for all platforms.

#### **Change Requests Resolved for All Platforms**

Change Request	Change Description
VEMOVE-493	Corrected an issue that occurred when generating the monthly reports that resulted in negative values in some counts on the report. This error occurred when exceeding the highest value that could be held by the summing variable. The variable that holds the sum total for the Customer Service Log (CSL) Report generation has been expanded to accommodate a value exceeding 2 billion.
VEMOVE-499	Corrected functionality of the VMA -s switch that is designed to silence all basic output messages. The -s switch was displaying some messages but has now been corrected to silence all basic output messages and only display error messages.
VEMOVE-505	Corrected an issue with the Unix database explode process where a "1" was returned when the process completed successfully but a "0" should have been returned. The explode script has been changed to output "0" when the explode process completes successfully.
VEMOVE-509	Improved VeriMove™ Access processing to use the proxy server settings stored in the VeriMove Access configuration utility instead of using values specified on the command line.
VEMOVE-520	Added information on the VeriMove Access error codes to Chapter 7, Troubleshooting in the VeriMove <sup>TM</sup> User's Guide.
VEMOVE-521	Corrected an issue where vma.exe only returned the HostedEvent.log and Verimove.info logs when a job successfully processed to completion. Processing has been corrected to generate the error logs when a processing error occurs.
